

**Short term drafting deadlines for the implementation decrees and decisions (within the next 6 months)**

- 1- Regulate the right of the state to seize private water rights for public interest against just indemnification. (art 34, MoEW + COM)
- 2- *Regulate the issuance of water Usufruct licenses.*(art 35, MoEW + COM)
- 3- *Conduct the national survey of all unlicensed built facilities.* (art 36, decision from MoEW)
- 4- Organize the operating procedures (by-laws) of the National Water Council. (Decision, art 14, NWC + Prime Minister)
- 5- Request a formal opinion from the Department of Legislation and Advice within the MoJ, as to whether or not municipalities and their federations: (i) may still build and/or operate water related projects without a formal agreement with WEs; and (ii) may still levy sewage tax (formal letter from MoEW, art 56)
- 6- Set the tariffs for service against water services (decision, art 75, WEs)
- 7- Set the tariffs/indemnities for the preservation of water resources and the protection of water systems (decision, art 75, WEs)
- 8- Set the special accounting plan for each service (decisions, art 44, WEs)
- 9- Develop, keep and update the irrigation register (decision, art 74, WEs)
- 10- Regulate the procedures through which the Water Basin Master Plans are developed (art 21, MoEW + COM)
- 11- Regulate the system to classify the basins and water regions (decision, art 22, MoEW)
- 12- Issue the individual basins and water regions action plans (decision, art 23, WEs)
- 13- Set the details for the implementation of Article 84 WL related to the protection of water collections sites, in addition to the details related to the allocation of spring water to supply the inhabitants or other usages (art 84, MoEW + MoE + *Competent Admin. Authorities*)
- 14- Set the measures required to guarantee the sustainable management of water (decision, art 87 & 88, MoEW + WEs)
- 15- Set the rules applicable to the connection to the water grid (decisions, art 63, WEs)
- 16- Set the rules applicable to the oversight and management of the non-public wastewater installations (art 73, MoEW + *Competent Admin. Authorities*)
- 17- Set the rules applicable to the connection to the wastewater grid (Decisions, art 63, WEs)
- 18- Provide for the detailed rules granting employees authorities of the water judicial police (art 94, MoEW+MoJ+ *Competent Admin. Authorities*)
- 19- Develop templates recommended for the annual reports to facilitate their drafting by the MoEW and WEs (decision, MoEW)

**MT : Medium term drafting deadlines for the implementation decrees and decisions (within the next 10 months)**

- 1- Organize the rights and obligations deriving from the rights of Water Usufruct (decisions & decrees, art 5; WE+MoEW)
- 2- *Identify the waterway's banks, boundaries, and retreats [protected areas]* (art 8, MoEW + *Competent Admin. Authorities*)

- 3- Regulate the conditions and terms of use and forfeiture of the acquired rights and/or their suspension to face any water deficit (art 12, MoEW + COM)
- 4- Regulate the traditional use of water for irrigation (art 33, MoEW + Competent Admin. Authorities)
- 5- Regulate the details applicable to the establishment of water users' associations (art 75, MoEW + COM)
- 6- Set the indemnity due against damages caused by pollution (art 51, MoEW + Competent Admin. Authorities)
- 7- Regulate the organization and management of the water registry (art 13, MoEW + Competent Admin. Authorities)
- 8- Regulate the register of Water related Works *مدونة* organizing the information and rules applicable to the water equipment, facilities, operations and works provided for in article 27. (art 28, MoEW + Competent Admin. Authorities)
- 9- Issue the General Water Master Plan, including in the General Water Master Plan all the elements developed in the strategy (art 17, MoEW in collaboration with the WEs and the MoE, MoA, MoPW, MoI; also following debate by the NWC + COM)
- 10- Issue the Water Basin Master Plans (decision, art 21, MoEW in collaboration with WEs)
- 11- Set the Water Quality Standards (decision, art 24, In coordination with the MoEW and MoE + LIBNOR)
- 12- Set the rules applicable to the equitable distribution of water to the various users (decisions, art 30, WEs)
- 13- Determine the perimeter of protection for water collection by decisions of the minister and/or all the ministers concerned within the framework of their respective competencies (art 84, MoEW + Competent other Ministries)
- 14- Provide for the rules and regulations applicable for the prevention of floods (art 86, MoEW+MoE+MoPW+MoA+Competent admin. Authorities)
- 15- Compile all irrigation related provisions of the various applicable law to pave the way for the drafting of a model unified irrigation law (draft Law, MoEW)
